CORRIGENDUM/ADDENDUM

Reference : **Advertisement dated 15/03/2023 and corrigendum/addendum dated 17/04/2023 for recruitment of constable (Technical/ Tradesmen) in CRPF, published in employment news dated 25-31 March,2023.**

1. Refer to advertisement No. CBC19140/11/0022/ 2223, EN 52/98 dated 25-31 March 2023 and corrigendum No. CBC19140/11/0002/2324, EN 5/98 dated 29 April – 5th May 2023, the following amendment is issued in compliance to the Court orders passed by the Hon'ble High Court of Delhi vide Judgment dated 15/05/2023 on WP No. 5460/2023.

- (i) In the light of Judgement of Hon'ble High Court Delhi, the para No. 20.3.12 of advertisement No. CBC19140/11/0022/2223, EN 52/98 dated 25-31 March 2023 is hereby amended and all the applicants are allowed to give three options/preferences of the trades of CT(Technical & Tradesmen), Pioneer staff and Ministerial cadre staff, after conduct of CBT and before declaration of result, which shall be decided as per the merit/option and vacancies in each trade.
- (ii) In the light of Judgement of Hon'ble High Court Delhi the clarification with regard to para-1 of corrigendum/addendum dated 17/04/2023 is hereby issued that the upper age relaxation of three years, granted by the Govt. of India/MHA will be applicable for all the applicants for the post of CT(Technical & Tradesmen), Pioneer staff and Ministerial cadre staff as **one time measure** in addition to the existing age relaxation.

2. In reference to advertisement No. CBC19140/11/0022/2223, EN 52/98 dated 25-31 March 2023



the following amendment in the vacancies is issued due to 1st cadre review of Group-‘C’ Tradesmen cadre :-

3. Vacancies of other posts will remain unchanged.

Since the vacancies of CT/SK (Female) and CT/Washer Woman (Female) are abolished, hence the applicants are allowed to appear in CBT opting for other posts available for female candidates viz CT/Bugler(Female), CT/Cook(Female), CT/Water carrier (Female), CT/Hair Dresser(Female) and CT/Brass Band(Female) if they desire so. The same admit card issued earlier will be applicable. The option/preference will be given after conduct of CBT and before declaration of result.

6. All the candidates are advised to regularly visit CRPF website for necessary information with regard to submission of options/preferences. The link will be available on 25/07/2023 for submitting options/preferences.
7. All other details in the advertisement dated 15/03/2023 as well as corrigendum/addendum dated 17/04/2023 will remain unchanged.
