**Notification**

G.S.R.(E).\_\_\_\_\_ In exercise of the powers conferred by sub-section (1) of section 18 of the Central Reserve Police Force Act, 1949 (66 of 1949), the Central Government hereby makes the following rules further to amend the Central Reserve Police Force Group "C" (General Duty/Technical/ Tradesmen) Cadre Recruitment Rules, 2010, namely:-

1. (1) These Rules may be called the Central Reserve Police Force Group "C" (General Duty/Technical/Tradesmen) Cadre Recruitment (Amendment) Rules, 2015.
- (2) They shall come into force on the date of their publication in the official Gazette.
2. In the Schedule to the Central Reserve Police Force Group "C" (General Duty/ Technical/Tradesmen) Cadre Recruitment Rules, 2010,-
  - (1) against Sl. No.(4), relating to the Post of Constable (Fitter), -
    - (a) under column (1), for the entry, the following entry shall be substituted, namely:-

"(4) "Constable (Mechanic Motor Vehicle)" ;
    - (b) under column (8) for items (i) and (ii), the following items shall be substituted, namely:-
      - "(i) Matriculate or 10 Class pass in 10+2 examination system from a recognised board or equivalent;
      - (ii) Possessing 02 years Industrial Training Institutes (ITI) certificate in Mechanic Motor Vehicle recognised by National or State Council for Vocational training or any other recognised institution and one year practical experience in the field of concerned trade.

OR

National or State apprenticeship certificate in Mechanic Motor Vehicle Trade of three year duration from a recognised institution and one year practical experience in the field of concerned trade.”;

- (c) under column (12), for the entry, the following entry shall be substituted, namely:-

“Constable (General Duty / Tradesmen) upto thirty years of age are being re-mustered after successfully qualifying Basic Auto Fitter Course and fulfilling all other eligibility criteria for direct recruitment for the post of Constable/ (Mechanic Motor Vehicle).”

- (2) against serial number (7), relating to the post of Head Constable (Fitter), under column (1), for the entry, the following entry shall be substitute, namely:-

“(7) Head Constable (Mechanic Motor Vehicle)”.
