- 5. <u>Number of Chances:</u> As per SOP, a total of 03 (three) chances will be given for appearing in LDCE. However, appearing in this combined LDCE for the vacancy year-2024 & 2025, only one (01) chance will be counted. The willing and eligible candidates will submit application as per **Annexure-A** to their respective Directorate General.
- **6.** <u>**The selection process:**</u> The selection process will be as under:

# 6.1 Written Examination:

There will be three papers in written test, as per details given below:

i) **<u>Paper-I</u>** (Intelligence Test and General knowledge).

(Time 2 hours – 100 Marks & 100 Questions) This will include General Awareness, General Intelligence, Reasoniñg, Numerical Ability, Current Events, Matters of every day observation and experience. This paper would be objective type (Multiple choice question & bilingual i.e. English and Hindi).

- ii) <u>Paper-II</u> (Professional Skill) (Time 2 hours- 100 Marks & 100 Questions) This will be designed to test professional skills of the candidate in relation to operational and administrative requirement of the Force of which he/she is a member. This paper would be objective type (Multiple choice question & bilingual i.e. English and Hindi).
- iii) <u>Paper-III</u> (Essay, Precis Writing and Comprehension) (Time 2 hours - 100 Marks ) The medium of writing of essay shall be opted by the candidate as Hindi or English. However, medium of writing précis and comprehension will be English only.
  - **Note**: Qualifying marks will be 45% in each paper and 50% in aggregate. However, qualifying marks for SC/ST candidates will be 40% in each paper and 45% in aggregate.
- iv) Admission for the written examination will be purely on production of call letter issued to the eligible candidates by the Nodal Force and Force identity Card of the candidates. Since, this examination is purely for CAPF personnel, all candidates shall be in proper **uniform**.

# 6.2 Physical Standard Test (PST) & Physical Efficiency Test (PET):

(I) The candidates who qualify in paper-I & II of written examination will only be called for Physical Standard Test & Physical Efficiency Test at place specified by the Nodal Force by constituting a Board of Officers. The Physical Standard Test (PST) will be conducted as per standards prescribed for direct recruitment of Assistant Commandant(GD) in CAPFs. Physical Efficiency Test shall comprise of the following components which will be qualifying in nature but failure even in one event will amount to disqualification:

## a. <u>Male Candidate</u>:

- (i) 100 meters race to be completed in 16 seconds.
- (ii) 800 meters race to be completed in 03 minutes 45 seconds.
- (iii) Long Jump 3.50 mtrs (Three chances will be given)
- (iv) Shot Put (7.26 Kgs.) 4.50 mtrs. (Three chances will be given)

# b. <u>Female Candidates</u>:

- (i) 100 meters race to be completed in 18 seconds.
- (ii) 800 meters race to be completed in 04 minutes 45 seconds.
- (iii) Long Jump 3.00 mtrs (Three chances will be given)

As per MHA ID No.45020/05/2021-PP/897 dated 31/08/2022, on reporting of female candidates for PST (Physical Standard Test)/PET (Physical Efficiency Test), a self declaration indicating about her pregnancy status shall be submitted. She may be allowed to participate in the PST/PET only if she declares that she is not pregnant. In case of false declaration, all the risk for undergoing PST/PET will be of her own. If the female candidate declares that "she is pregnant" before PST/PET, then a confirmatory pregnancy test will be done and in case she is found to be pregnant, irrespective of duration of pregnancy, she may be declared temporary unfit and her appointment shall be held in abeyance till the confinement is over. One vacancy should be kept reserved for her in case she makes in the final merit list . She should be reexamined for PST/PET six weeks after the date of confinement, subject to the production of the medical certificate of fitness from a registered medical practitioner. If she is found fit and finds place in the merit list, she may be appointed to the post kept reserved for and allow the benefit of seniority in accordance with the instructions of the Government, as amended from time to time. In case female candidates is found negative for pregnancy, she may be allowed to participate in the PST/PET and other subsequent processes.

(II) One officer of the rank of DIG will be nominated as Appellate Authority at PST/PET venue to dispose off PST/PET appeals, if any, of candidates on the same day.

## 6.3 Interview and personality Test:

The Candidates who qualify written examination by securing required aggregate percentage of marks in Paper-I, II & III, as well as qualify Physical Standard Test and Physical Efficiency Test would be called for interview by the Nodal Force. The Interview will carry **100** marks and the break- up of marks will be as under:-

**Note:** In the Interview, there are no minimum qualifying marks but attendance is mandatory. Marks obtained in Interview/personality test will be accounted for during drawal of final merit.

## 6.4 <u>Medical Examination:</u>

The candidates who qualify the written examination, PST/PET and Interview, shall be eligible for undergoing medical examination to be conducted by the duly constituted Medical Board of concerned CAPFs. The medical examination will be conducted as per revised Medical Guidelines issued by MHA vide UO No.A.VI-1/2014-Rectt(SSB) dated 20.05.2015, F.No.32012/ADG(Med)/DME&RME/DA-1/2020(Part File)/ 1166 dated 31.05.2021 and amended from time to time for recruitment of GOs and NGOs in the CAPFs and AR. There would also be a provision for Right to Appeal as per the existing guidelines. The Review Medical Examination will be in continuation of Detailed Medical **Examination**. However, there is no provision of appeal against Review Medical Examination (RME) and the decision of RME board would be final.

## 6.5 <u>Merit List:</u>

On completion of above processes in all respect (stage wise), the Nodal Force shall prepare the force wise and category wise **final merit list of the candidates for each vacancy year separately, as per the eligibility of the candidates for respective Forces and the result will be declared in two phase one for year 2024 and other for 2025.** A list of finally selected candidates (Force wise) will be sent to respective Directorate General by the Nodal Force for issue of offer of appointment.

**Clarification:** If a candidate fulfils all the eligibility criteria and qualifies all the stages for both the vacancy years 2024 & 2025 and finds place in the merit for both years, then for giving him/her the benefit of seniority, he/she will be considered first for the year 2024 followed by 2025. Further, if a candidate is eligible for only one vacancy year, his/her selection will be considered for that particular vacancy year only, irrespective of marks obtained in comparison of candidates eligible for other vacancy year.

## 7. <u>Tie Principle:</u>

In case, two or more candidates have secured equal aggregate marks, the tie(s) will be resolved in accordance with the following principles:

- a) If the marks in aggregate are equal, the candidate getting more marks in written total will be ranked higher.
- b) If the marks in written total are equal, the candidate getting more marks in Paper-I (Intelligence Test and General Knowledge) and Paper-II (Professional Skill) will be ranked higher.
- c) If the marks in Paper-I (Intelligence test and General Knowledge) and Paper-II (Professional Skill) are also equal, the candidate senior in age will be ranked higher.
- 8. No TA/DA, journey expenses are allowed for attending the test. The period of the test will be treated as on leave for the candidates appearing in the test, which would be sanctioned by the leave sanctioning authority.

# 9. <u>Training/Probation</u>:

The selected candidates shall undergo training at the training centre of respective Forces and they will remain on probation for a period of two years as per recruitment rules for the post of Assistant Commandant (GD).

## 1c. <u>Submission of application</u>:

- (i) **The Directorate General of CAPFs will further circulate this advertisement**, SOP and its related instructions to their field formations for obtaining the applications of eligible candidates.
- (ii) The eligible candidates shall apply for the post in the prescribed format attached with this Notification as **Annexure-'A'** to their respective Directorate General through proper channel. At the time of filling application form, **candidates will have to clearly mention vacancy years for which he/she is eligible, ie. 2024, 2025 or both.**
- (iii) Applications should be supported with proof of the Date of Birth, Educational Qualification, Caste/Tribal Certificate issued by the Competent Authorities, Certificate for completing length of clean service (as prescribed in RRs of respective CAPFs) after verification/checking from service records (as per annexure-D), ACRs/APARs for last 05 years and Disciplinary/Vigilance clearance Certificate/SHAPE-I Medical Category. However, no marks will be allotted for documentation. No direct correspondence by the candidates, in this regard should be made with CRPF Directorate.
- (iv) The concerned Directorate General of CAPFs shall accordingly collect applications from willing/eligible candidates of their Organization, consolidate applications properly, entered serially in a register in the chronological order of the receipt. Preliminary screening of applications as per checklist (Appendix-1) will be carried out by the concerned Force Directorate strictly as per eligibility conditions by constituting a Board of Officers and will forward the list of eligible candidates only showing eligibility of candidates for year-wise vacancy in hard and soft copy along with their Admit Cards (Annexure-B) to the Dy. Inspector General(Rectt), Directorate General, CRPF, East Block-VII, Level-IV, R.K. Puram, New Delhi-66 for allotment of Roll numbers to the eligible candidates. The applications received after due date fixed for receiving or those found incomplete in any manner will be rejected by the concerned Force Directorate, duly recording the reasons for rejection in the register against the name of the applicant. Board Proceedings along with individual-wise Recruitment Dossier, containing all the papers including ACRs/APARs, (Annexure-A, C & D and Appendix-1 (Annexure-D-soft and hard copy), NOC etc. tagged should be prepared in separate file cover in each case & same should be serially numbered as per check list and retained by concerned CAPFs till hearing from Nodal Force (CRPF).
- (v) Application received after due date i.e. **21/03/2025** shall not be considered.
- (vi) Candidates must send the following documents with his/her application to their concerned Directorate General:
  - a. Admit Card duly filled in all respect and signed by the candidate with photograph pasted as per Annexure-B. (Candidates may download blank copy of application form and Admit Card from CRPF Recruitment website i.e. https://rect.crpf.gov.in)
  - b. Two identical copies of recent passport size (5 cms x 7 cms approx) photographs of the candidate in uniform, one pasted on the

application form and the other on the admit card in the space provided therein, duly signed by the candidate in such a way that part of signature falls in the application form and rest on the photograph.

- c. Self attested true copy of matriculation or equivalent certificate as proof of age.
- d. Self attested true copy of the certificates of education qualifications.
- e. Self attested true copy of caste certificate in case of SC/ST candidates.
- f. Service certificate/vigilance clearance as per specimen enclosed with the application (Annexure-C).
- g. Attested copy of latest SHAPE-I (One) Medical Category certificate.

### NOTE :-

- (I) Applications, which are not in prescribed proforma or not accompanied by the specified enclosures or incomplete shall be summarily rejected. No representation or correspondence regarding such rejection shall be entertained.
- (II) Candidates are not required to submit any original certificates in support of their claims regarding educational qualifications and other relevant certificates and will submit only self attested/certified true copies with their applications. If on verification, even at any later stage, it is found that any candidate does not fulfill any of the eligibility conditions; his/her candidature shall be liable to be rejected.
- (III) The applications of the eligible candidates received through respective CAPFs HQ will be allocated Roll Numbers by the Nodal Force (**CRPF**).
- (IV) Admit card for the written examination and venue of the examination will be issued to each eligible candidate by Nodal Force and will be communicated through their respective CAPFs HQ. If any candidate does not receive intimation, he/she may contact concerned CAPFs HQ and no personal enquiry will be accepted by CRPF.
- (V) Any change/amendment in recruitment process will be uploaded on CRPF Recruitment website i.e. https://rect.crpf.gov.in only. Hence, candidates, in their own interest, are advised to log on to the CRPF Recruitment website from time to time.

## 11. <u>Centre of Examination</u> :-

Date and time of written examination, Physical Standard Test (PST), Physical Efficiency Test (PET), interview and DME/RME will be intimated to the candidates through their respective Force by Recruitment Branch, Directorate General, CRPF, East Block-VII, Level-IV, R.K.Puram, New Delhi-110066. <u>The candidates are required to bring all their testimonials in</u> <u>original at the time of interview.</u>

**Note** : Admit card will be issued to the eligible candidates for appearing in the written examination only. No separate Admit card will be issued to appear for PST/PET/Interview and Medical examination. The list of eligible candidates will be circulated to concerned CAPFs for informing to the eligible candidates and will also be displayed at the Recruitment Centre, uploaded on CRPF Recruitment Website i.e.https://rect.crpf.gov.in

### 12. Guidelines for filling up the application form:

- (a) The application must be filled correctly and completely by the candidates Corrections, if any, should be legible and attested by the candidate.
- (b) Before filling in the application form, the candidates must read the eligibility conditions for the recruitment carefully to see if they are eligible. They should apply if they fulfill all the conditions to avoid disappointment at later stage.
