Educational qualification:- Post Graduate Degree/Diploma in concerned specialty. One and Half years experience after obtaining PG Degree. Two and half years experience after obtaining PG Diploma.

Note :-

a) Appointment is purely on contract basis and the initial period of appointment of contract will be for three years which may be extended for further 02 years on year to year basis subject to the Maximum age of 70 years.

b) On completion of tenure, the contract shall lapse automatically. However, the appointment can be terminated at any time (on either side) by giving one month's notice or by paying one month's notice or by paying one month's salary without assigning any reason or failure to complete three months service to the satisfaction of the competent authority.
