c) Contractual appointment can be terminated forthwith without paying one month's salary to the concerned in lieu of one month's notice in case selected candidate does not join duty in spite of repeated call up notices.					
d) The appointee shall not be entitled to any benefits like provident fund, pension, gratuity, medical attendance treatment, seniority, promotion etc or any other benefits available to the Government servant appointed on regular basis.
