- The deputation will initially be for a period of three years, which may be extended as per rules. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment on deputation in the same organization/department shall not exceed 4 years.

3. The terms of deputation will be governed as per DoP&T OM No 6/8/2009-Estt (Pay.II) dated 17<sup>th</sup> June, 2010, as amended from time to time.
4. The applications in the proforma (Annexure-I) may be forwarded through proper channel alongwith necessary certificate as per Annexure-II. Application not in prescribed proforma will be summarily rejected.
5. Incomplete applications and those received late and/or without the requisite enclosures would be summarily rejected. No correspondence in this regard would be entertained.
